## **GOLF EVENT TERMS AND CONDITIONS:**

Our rates for a tournament are the same as current in-season public pricing per-player. A refundable deposit of: 16-40 players \$400, 41-80 players \$800, 81-120 players \$1500, 121+ \$1900. Deposit will be held up to 72hrs to asses if/any security and damages. Deposit is due upon the signing of this Golf Event Contract. Tournaments must prepay all green fees 1 week(7days) in advance. Battle Creek Golf Course will release tee times to public for any time that hasn't been prepaid.

The FINAL PAYMENT is based on final head count for all players, including all tournament volunteers, must be made no later than 1 week(7days) before the tournament date. The final payment is based off of final headcount, the total number of players in your tournament. Please make checks payable to Battle Creek Golf Course. Groups arriving with fewer than the final head count will be charged per this agreement. If fewer golfers play, NO REFUNDS will be given. Battle Creek Golf Course may fill empty spots with paying public play at their discretion. If final payment has not been made 1 week(7days) before the tournament date, the tee sheet time(s) will be released to the paying public.

No outside alcohol, personal coolers, or containers are allowed.

**SIGNAGE** Battle Creek Golf Course will place and remove, at no additional cost, any signage utilized by the tournament. Signage must be claimed by each event and removed from the property at the conclusion of the event. If the signage is not claimed with 48 hours after the tournament, the signage will be assumed to be abandoned and will be discarded.

**CANCELLATION POLICY** You may cancel your event, with a full refund, 2 weeks(14 days) prior to your event date. NO REFUNDS will be given if canceled within 2 weeks(14 days) prior to your event date.

It is the sole discretion of Battle Creek Golf Course to determine if weather is cause for cancellation on the day of the event. If, in our opinion, an event must be cancelled due to

weather, you will have the option to reschedule for another day. Once an event begins, there will be NO REFUNDS.

**INCLEMENT WEATHER** Cancellation of the tournament will be considered only if Battle Creek Golf Course officially closes the course to all play. The tournament will be rescheduled based on date availability and/or requested rain date.

**INDEMNIFICATION** You hereby jointly and severally agree to indemnify, defend and hold Battle Creek Golf Course and Battle Creek Golf Course Cafe harmless from all claims, suits, actions at law, judgments, liabilities, losses and damages (including attorney's fees) arising from your use of Battle Creek Golf Course property, however caused, including without limitations, any injury or damages resulting from negligent, careless, improper or unlawful conduct.

**DAMAGES** You agree to exercise extreme caution when operating equipment (specifically but not limited to golf carts, pull carts, golf clubs, golf balls) and utilizing the golf course property. In the event that you cause damage to the property and/or equipment used by your participants, you agree to pay us in full for any damages.

**GOLF CART AGREEMENT** No more than 2 persons per golf cart and no more than 2 bags per golf cart at any time. Persons under the age of 18 and/or do not possess a valid driver's license are not permitted to drive a golf cart at any time. Golf cart must stay back 30 feet from greens, tees and water hazards at all times. No cart is permitted on levees at any time. Drive carefully. Maintain a firm grip on the steering wheel at all times. Do not spin wheels. Golf cart parking brake must be engaged and set before leaving golf cart. Battle Creek Golf Course reserves the right to refuse the use of carts to any person not following these and other rules without refunding fee. If not told otherwise, always use the 90 degree rule with your golf cart. The renter and / or renters are financially responsible for any damage done or cause by ill use and/or miss use of said golf cart resorting in damage to the golf course, golf cart and/or persons.

**CONDITIONS OF THE AGREEMENT** Performance of the agreement is contingent upon the ability of Battle Creek Golf Course management to complete the same, and is voidable in the event of labor dispute or strikes, accidents, government (Federal, State, or Municipal) requisitions, restrictions upon travel, transportation, food, beverages, or supplies, and or other causes, whether enumerated herein or not, beyond the control of Battle Creek Golf Course, preventing or interfering with the delivery of services required for the tournament. In no event shall Battle Creek Golf Course be held liable for other damages.

**EVENT TERMS AND CONDITIONS AGREED TO:** Signature below indicates full consent with all of Battle Creek Golf Course event terms and conditions including, but not limited to, payment, player count, golf cart agreement, outside alcohol, personal coolers, and cancellation policies.
